Description of the course: This one-year course covers general topology and algebraic topology. From general topology we will discuss: topologies, bases, subspaces, metric spaces, compactness, connectedness, and separation properties. Core theory will include the Uryson's Lemma, the Tietze Extension Theorem, the Tychonoff Product Theorem, and Stone-Ćech compactification. From algebraic topology we will cover the definition and computation of simplicial homology, fundamental groups with applications and computations, covering spaces, and an introduction to cohomology. The instructor will provide handouts covering all material.

Learning outcomes: The students should develop and understanding of basic concepts and relations of general and algebraic topology. They should also learn how to compute homology groups and fundamental groups.

Assessment of learning outcomes: Each semester there will be a final exam worth 50% of the final score. Homeworks will be given but not corrected. Instead, there will be *three* in-class midterm exams in which some homework problems and some theoretical facts will be tested. These exams will be worth, combined, the remaining 50%.

How to study? First, you should attend the class regularly, and follow what the professor is teaching. Read the classroom notes. Do the homework regularly. If you have any questions, past or present, ask them in class. Listen to teacher's explanation carefully. If this all fails, come and ask for help and advice during the office hours.
